Also, I understand that it is my responsibility to notify Marine Services, Torbay Council if my income circumstances change and that any discounted harbour dues may be discontinued. If I accept discounted harbour charges that I am, for whatever reason, not entitled to receive, I agree to pay the difference between the discounted dues and the appropriated level of harbour charges.
