She has taken on more complex cases and has been involved with Safeguarding Meetings. She has identified what information JH wanted sent to her. Appendix 1 will help identify what the Housing Needs are. JD also needs to link up with SBr (Supporting People Service Development Officer for Children, Young People and Families) and talk to the Children with Disabilities Team. JD had asked for details of all children over 10 who will need accessible housing in the future but had not received a reply to this request- LW to follow this up. JD will speak to the Zone Leads about their front line staff completing the Appendix 1 Proforma in the future. Once this has been done JG will raise it at the Personalisation Board. JD advised that according to Devon Home Choice there is no need for “fully wheel chair accessible homes” in Torbay. This is rather worrying as she has a list of 40 people needing this. She will go through her list with Devon Home Choice and investigate the reason for them not being registered as needing wheelchair accessibility.
